Type	Type of cabin	Description
I	2-persons	Stern quarter-deck cabin , double bunk, exit on deck nearby, full sanitary unit and new cabins in the stern part, cabin A - 2 storey single bunk, cabins B i C – two single bunks, full sanitary unit
II	1-person	Cabin in the stern part, full sanitary unit
III	2-persons	Cabins in the officers part, two storey single bunks with a sink, bathroom and a washing room in the hall
IV	10-persons	New students cabins in the amidships, storey bunks, no sink included, access to students ablutions

Additional information:

- The above prices are BRUTTO prices (with VAT included).
- The price is calculated for every started hotel day (hotel day starts from 4 p.m. until 3 p.m. next day; the hours may vary due to the time of entering/leaving the port).
- The price includes three meals
- The necessary personal accident insurance on time of the journey and medical certificate about a lack of contraindications as to the journey
- In the event of underage persons it is necessary to include parental/both legal guardians permission.
